SA clients can pick rams up on the day or rams can be delivered by arrangement. If you are picking up rams there will be multiple loading ramps and help with loading.


Other states/territories clients, we have options depending on the situation at sale time but can guarantee access for pick up or delivery.

Using the TCP index

The TCP index, unlike Carcase Plus, is on a scale that is aligned with other Sheep Genetics' indexes and is represented in economic terms with a unit increase in the index reflecting an additional dollar per ewe joined per year.

To assist in comparing rams, Sheep Genetics recommends using a percentile band table as reference. The figure below, which is based on the percentile band table, highlights the TCP index value for significant percentiles for the 2018 drop animals.




